Subject: IMPLEMENTATION OF CODE OF CONDUCT FOR FEMALE HOSTELS

- 1.0 Provost (Female Hostels) proposed Code of Conduct for Female Hostels in order to maintain safety and security of the hostilities, formalization of the permission and mechanism for regulating the movement of female students. The Code of Conduct were discussed and recommended for implementation by Hostel Advisory Board. The details of the code of conduct are given below.
 - Slip limings for female hostel in all blocks is 08:00 p.m. to 09:00 p.m.
 - 2. Outgoing slips will be provided on Thursday, Friday and Salurday
 - Home going slips will be provided on all days.
 - No permission slip will be issued without presenting hostel card.
 - 5. No one can leave the hostel after Maghrib.
 - 6. No one is allowed to enter the hostel after one hour of Maghrib.
 - 7. Hostel timing are 7.30 pm in summers and 6.30 pm in winter
 - Exceptions and emergencies must come with application forwarded from respective HOOs.
 - 9. Late classes and Library students must submit their names attested by their HODs to Wardens for late entry.
 - 10. Security quards are required to check the hostel cards of students at time of entry and exit.
 - All hostilities are required to ensure their physical presence at night during attendance which will be taken from 9:00 p.m. 10:00 p.m.
 - 12. Students who remain absent for consecutive 3 days without permission allowill be ceased from the hostel.
 - 13. Any illegal stay noticed, will immediately be reported to the security office.
 - 14. If any girl has been noticed involved in drinking, smoking, steeling or any other immoral activities, their case will be forwarded to the University Discipline Committee and Chief Security Office, IIUI.
 - 15. Any illegal activity noticed by authorities will lead to the cancellation of the seat immediately without any further notice.
 - 16. Day Scholars are not allowed to enter in the Hostel premises.
 - 17. No guests are allowed. Special permission must be obtained from Director Office, Female Campus.
 - 18. Residents shall be allowed to use certain specified electronic appliances on prescribed rates. They shall seek formal approxisel of Residant House Turtovirurden for the rise of these appliances on permissible locations. Spot checks shall be made by resident House Tutors or their representatives. Defaulters or unauthorized use shall be subject to fine and/or desophinary action as the case may be.
